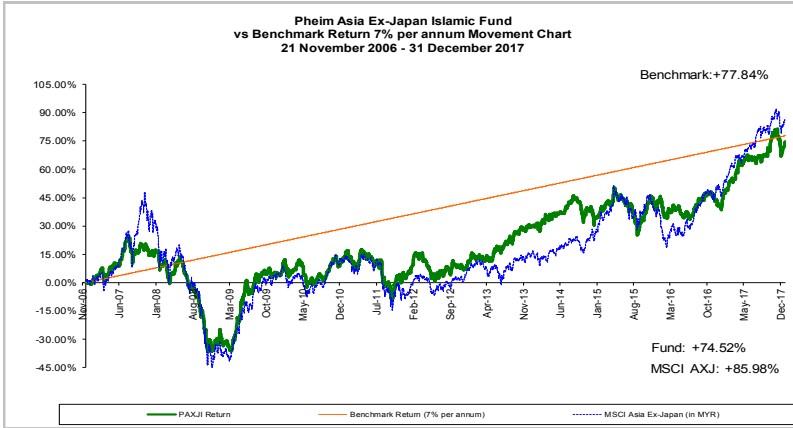


Investment Strategy

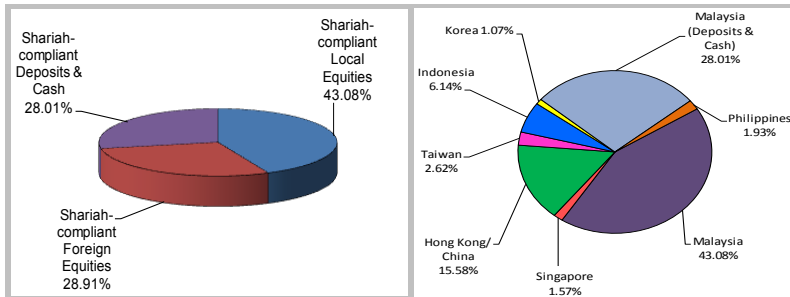
The Fund will invest in securities listed on the stock exchanges of the Asia Pacific region excluding Japan that comply with Shariah requirements.

 Minimum 70% and up to a maximum of 95% in Shariah-Compliant equities.
 Sukuk and shariah-based liquid assets for remaining balance not invested in equities or equity related securities.
