Investment Strategy

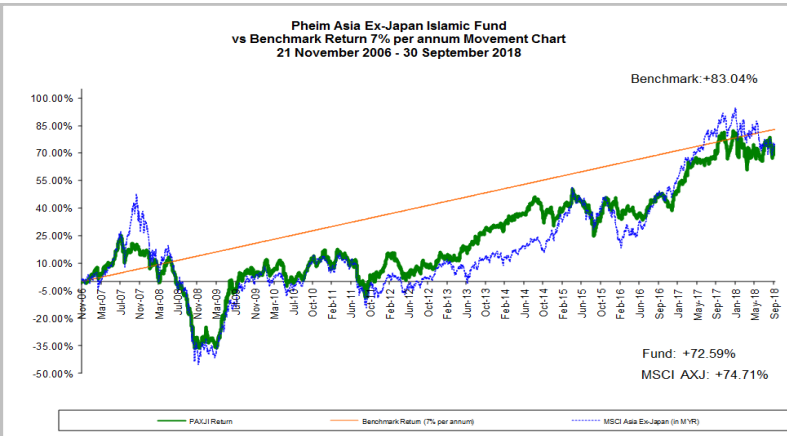
The Fund will invest in securities listed on the stock exchanges of the Asia Pacific region excluding Japan that comply with Shariah requirements.

The Fund's asset allocation is:

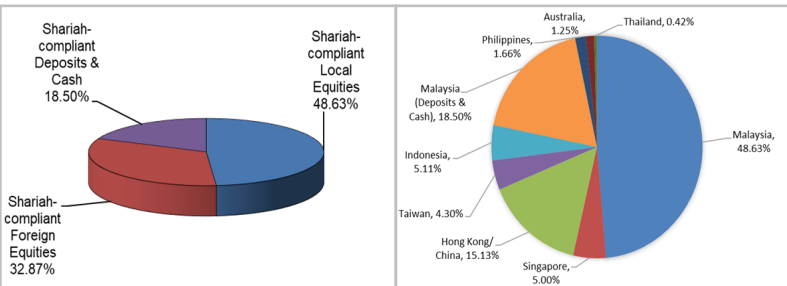

The VF means there is a possibility for the fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF of qualified funds. VF is subject to monthly revision and VC will be revised every six months. The fund's portfolio may have change since this date and there is no guarantee that the fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
