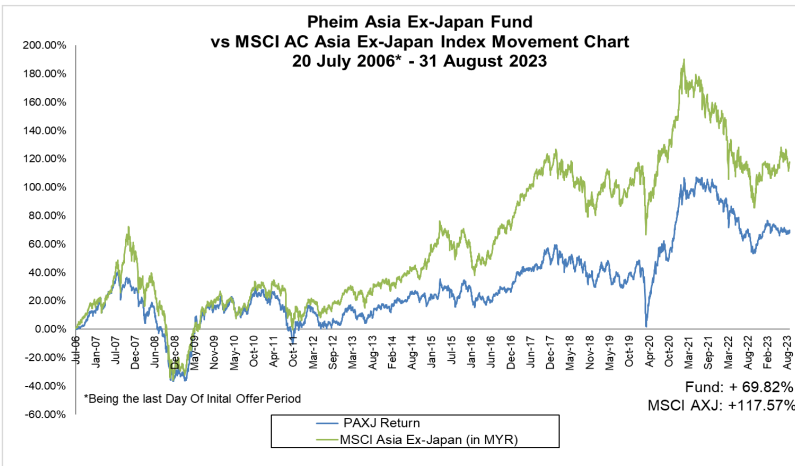
Fixed income instruments and liquid assets : Remaining balance not invested in equities or equity-related securities.

Fund Objective

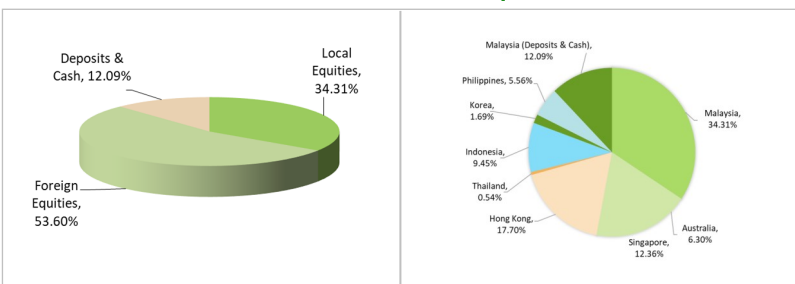
